## Food Accommodation Policy

In order to protect students who have food allergies, Paradigm requires children who have food accommodations to supply their own NUT FREE snacks and meals each day, regardless of what is listed on the menu to be served that day. Meals and snacks brought in are not stored in the refrigerator and must come prepped and ready to serve, just like a sack lunch you would send in elementary school. Additionally, Paradigm asks that all children, with the exception of infants, not to bring outside food into the building, unless that child requires a food accommodation due to an allergy or other reason such as religion.
